2. PROJECT PROGRESS

2.1. Narrative of project progress during the past semester by Project Activity¹

1.1.1 BV & EWT develop better understanding of respective Madagascar & Mozambique programmes, communities and situations

During this reporting period, BV & EWT developed a better understanding of their respective Madagascar & Mozambique programmes, communities and situations. Firstly, through the learning trip detailed below (1.1.2), secondly through the needs assessments being conducted for health (1.1.3) and livelihoods (1.1.4), and thirdly through regular meetings and conversations to share information. These activities have enabled BV's PHE Support Officer and EWT's Project Coordinator, as well as the wider BV and EWT teams, to develop a clear understanding of BV's approaches to improve community engagement in local marine management, as well as a shared vision for the initiatives that EWT intends to implement under the GEF Dugong and Seagrass Conservation Project in the Bazaruto archipelago.

1.1.2 Learning trip to Madagascar for relevant EWT staff to understand community-led incentive-based coastal conservation & development models more fully

The learning trip took place in March 2016, with EWT's Project Coordinator and Programme Manager spending five days at BV's site on the west coast of Madagascar. It included a tour of the village in which BV is based in order to develop an understanding of the community and context, followed by introductory presentations of BV's work, a capacity self-assessment exercise in order to identify EWT's learning objectives and capacity development goals. Additionally, BV's team provided a variety of technical training sessions on topics ranging from fisheries monitoring and reproductive health to seaweed farming and integrated community outreach methods, followed by visits to a number of neighbouring villages: meeting with community health workers, seeing the seaweed farms in action and observing youth engagement activities. The learning didn't stop with the organised sessions and visits; from early morning sunrises to dinners, the conversations continued.

"The learning visit was incredibly useful. We now have a scaffolding around which we can build our project and a network of support that is essential for any project to have a positive impact... It was only a 'five-day' exchange but the BV team made it possible to absorb years of experience!" – EWT's Project Coordinator.

1.1.3 Community needs assessment and health partner mapping for the development of an integrated Population-Health-Environment (PHE) programme in the Bazaruto archipelago

The community health needs assessment is currently underway, with social survey questions and focus group topics prepared in order to assess: community strengths and problem-solving histories; health-related knowledge, attitudes and practices; existing access to health information and services; major health problems; typical preventative and care-seeking behaviour; unmet family planning needs; desired access to health information and services; women's roles in the community. This activity commenced a little later than planned, as EWT's Project Coordinator and BV's PHE Support Officer were unable to start work in Bazaruto until mid/late May for logistical reasons. The community health needs assessment is therefore anticipated to be completed by the end of September.

Health partner mapping and engagement is also currently underway, with several meetings held with district health officials in Vilanculos and Inhassoro. These suggest promising potential for collaboration around increasing access to family planning services, initially on Bazaruto island for the pilot. Before proceeding any further, EWT is working to secure approval for their activities in Bazaruto from the district administrator and then more detailed discussions with the district health officials can resume. Potential for collaboration with other health partners is also being explored, with meetings arranged with health agencies including Pathfinder International and FHI 360 in July.

1.1.4 Needs assessment for alternative livelihoods, and other incentives, for communities in the Bazaruto archipelago

The livelihoods needs assessment has been completed, with survey results indicating that roughly 75% of the population are involved directly in fisheries as a livelihood, in particular, seine-netting. However, most fisher families also supplement their income with other activities. The average monthly income is ~\$52. These findings, in combination with conversations held during focus groups, suggest that communities on Bazaruto island want alternatives to supplement their income, in particular during the period (3 months from June to August) of seine-net closure. In response to these findings, EWT is assessing the feasibility of developing a pilot seaweed farming initiative with the aim of providing communities on Bazaruto island with alternatives to fishing.

1.1.5 Pilot PHE programme developed in the Bazaruto archipelago

This pilot PHE programme will be developed fully once the results of the community health needs assessment are analysed and agreements with health partners have been signed. In the meantime, EWT's Project Coordinator and BV's PHE Support Officer are in discussions with Bazaruto National Park staff regarding their understanding of community needs, and exploring possible interventions in order to inform and develop thinking around this pilot PHE programme. The plan for this pilot PHE programme is anticipated to be developed by the end of October.

1.1.6 Pilot alternative livelihood programme developed

Preparations for the pilot seaweed farming initiative are currently underway, with EWT's Project Coordinator in touch with BV's Madagascar-based Aquaculture Programme Coordinator to discuss options for sourcing high quality seaweed. BV's Aquaculture Programme Coordinator has prior experience working in Vilankulos, and may be available to visit the site later this year to provide some technical advice in-person. In the meantime, EWT's Project Coordinator is also in contact with BV's Madagascar-based private sector partner (seaweed export company) Copefrito regarding value chains for seaweed in Mozambique. Should large-scale seaweed farming prove to be viable in the Bazaruto archipelago, Copefrito would be open to purchasing it from local communities for international export. To fully investigate the feasibility of seaweed farming in the Bazaruto archipelago, EWT is planning to carry out an environmental impact assessment.

1.1.7 EWT programme staff needs assessed

EWT programme staff needs were assessed during the Madagascar learning visit, and conversations are ongoing between EWT's Project

Coordinator and the wider BV team regarding additional staff capacity that may be necessary in order to deliver this project. Once the community health needs assessment is completed and the feasibility of seaweed farming is clear, we will consider recruiting local staff members to support health outreach and aquaculture development, or consider paying a few local community members small stipends for their dedicated assistance with these activities. We anticipate making a decision about the recruitment of additional staff or dedicated community liaison officers by the end of the year, and will provide them training and supervision as part of this project.

1.1.12 BV support for both programmes continued through field visits, remote technical support, etc.

BV support for both programmes is being delivered by a PHE Support Officer on-site in Bazaruto 50% of the time, working alongside EWT's Project Coordinator. This is a more intensive level of support than was anticipated in the original project plan, thanks to additional funding secured by BV for this work. Further remote technical support is being provided by BV's Health-Environment Partnerships Manager, Conservation Director and Aquaculture Programme Manager through regular emails and periodic Skype calls. BV's Health-Environment Partnerships Manager is due to visit Bazaruto in mid-July to discuss preliminary findings from the community health needs assessment and agree on next steps for the development of the pilot PHE programme with EWT's Project Coordinator.

3. MONITORING AND EVALUATION

3.1. Please describe activities for monitoring and evaluation carried out during the reporting period.

Examples include: baseline data collection, stakeholder surveys, field surveys, steering committee meetings to assess project progress, peer review of documentation to ensure quality, mid-term review, etc. Do not include routine project reporting.

Alternative livelihoods can be used to mitigate high levels of marine resource exploitation. The potential for the introduction of alternative livelihoods in the Bazaruto archipelago was investigated during the reporting period through a livelihoods assessment. 76% of community members interviewed are predominantly fishers (mostly seine-netters) but supplement returns from fishing with multiple other sources of income. With an average monthly income of \$52 - which is well below the country average - and the already present culture of partaking in multiple occupations, it was concluded that introducing alternative livelihoods designed to decrease marine resource exploitation (including pressure on seagrass habitats and dugong populations) has the potential for success within the Sitone community on Bazaruto island.
