#### 2. PROJECT PROGRESS

### 2.1. Narrative of project progress during the past semester by Project Activity<sup>1</sup>

- 4.1.1 Facilitate symposium to collect baseline data and project final status

  The second symposium is planned to be conducted in October 2018.
- 4.1.2. Develop Dugong and Seagrass National Plan of Action (NPOA) Accomplished
- 4.1.3. Legalize Dugong and Seagrass NPOA

A meeting on 31 January 2018 was conducted by Legal Bureau of MMAF and attended by representative of six MAF Director Generals (DGs). Draft of ministerial decree on NPOA of marine mammals, which is consisted of Cetacea and Dugong NPOA, was discussed including the mechanism of the NPOA implementation. Some adjustment in the NPOA was resulted, such as the implementation time starts from 2018, and the action plan be briefer and clearer according to DGs job description and available budget.

More technical meetings were held to improve the NPOA, including to revise the draft of English version.

The draft of Ministerial Decree has been approval respectively by Directorate General of Marine Spatial Management, Directorate General of Surveillance for Marine and Fisheries Resources, Marine and Fisheries Research and Development Agency. The draft now is being reviewed by Directorate General of Capture Fisheries. Afterward there are two DGs left to get approval of Minister of MAF, namely Directorate General of Aquaculture and Directorate General of Product Competitivenes.

- 4.2.2. Facilitate NDCC regular meetings

Several internal evaluation and coordination meetings were conducted and lead by CMB-MMAF on 16 January, 19 February, 1-2 March, 4 May, and 18 May 2018 as ways to 1) assess DSCP Indonesia progress (ID1, ID2 and ID3) and activity plan, 2) measure DSCP Indonesia disbursement and present budget forecast, 3) synchronize activities across different IDs and institution, 4) accelerate DSCP Indonesia implementation. From this internal meeting the latest state of DSCP Indonesia is known and strategic actions can be planned.

4.3.1. Participate in Executive Project Steering Committee for focal point/Project Coordinator
No activity of EPSC meeting in this period. However, the relevant activity is to follow up the last EPSC meeting, namely writing on the Driver,
Pressure, State, Impact, Response (DPSIR) analysis. DSCP Indonesia worked on DPSIR analysis for dugong and seagrass conservation in
Indonesia. Three meetings on 14 March, 9 May and 26 June 2018 were held to discuss this matter at national level. The first draft of DPSIR
was reviewed by policy advisors of DSCP, afterward it was followed up through the third meeting. At the moment the latest drafts of
Indonesian dugong and seagrass DPSIR has been submitted to the policy advisors.

Some administrative issues was discussed also, it was decided that each PIC shall submit a monthly budget plan on the 5<sup>th</sup> of every month for next month's activities, and submit the past month activity results and its administrative on the 25<sup>th</sup> of every month to WWF.
