2. PROJECT PROGRESS

2.1. Narrative of project progress during the past semester by Project Activity

3.1.1. Prepare map on status, distribution and threats on dugong and seagrass

Information on dugong and seagrass distribution and threats in Indonesia is still being collected from stranding, entanglement/ bycatch, capture, and sighting reports gathered by the WWF-Indonesia, Whale Stranding Indonesia, LIPI, and occasional reports to Dugong and Seagrass Conservation Project (DSCP) Indonesia. The newest design for maps with the latest data from December 2017 have been available. The updated map have not been available yet due to it is still being processed related to cleaning and verify new data from Jan – Jun 2018 period.

3.1.2. Prepare standardized method for seagrass and dugong research and monitoring

Having undergone a massive change in the outline of the reports based on the 5 February 2018 meeting, the draft has been focused and updated for only 3 methods with consideration that the methods will be able to be implemented widely by relevant stakeholders in Indonesia and will help to gather data for dugong national database. The methods have been used by DSCP Indonesia during preliminary survey and some on-site in-depth researches in the last 2 years. Those 3 methods are UNEP-CMS Questionnaire, seagrass habitat monitoring (feeding trail and transect) and dugong monitoring with boat. The final draft is available in Indonesian and is in editing process.

3.1.3 Facilitate preliminary survey for updating site projects status

3.1.4. Facilitate training on seagrass and dugong survey and monitoring methods

To support the implementation of national questionnaire survey and to complete national database, a training on UNEP-CMS Questionnaire Survey was conducted in Jakarta on 30-31 January 2018. The training was attended by the PICs of 8 survey sites (Aceh, Mentawai, Bangka Belitung, Banten, West Nusa Tenggara, Sangihe, Maluku and Raja Ampat) and the team members survey. In 2 day-training participants learn how to design survey, how to conduct an interview, how to use Akvo Flow (even though in the end it was decided to do the survey manually), and how to do data input and tabulation. During the meeting, site PICs also discussed and agreed upon the scenario of survey that suitable to implemented in their sites. The field surveys were planned to be conducted between February and April 2018.

3.3.1. Standardize guidelines of research on carbon budget in seagrass

Four meetings to discuss and finalize the draft of the guidelines had been conducted in Jakarta on March 27th, 2018; April 6th, April 27th and 30th, 2018. The authors have agreed to revise the draft, especially for Chapter 1, 2, and 6, based of the suggestions received during the last meeting. The draft is available in Indonesian. The guideline is expected to be a national reference as an action to reduce green house gases and fight climate change.

3.3.2. Develop and update seagrass and dugong database

UNEP-CMS Questionnaire Survey was conducted nationally carried on from February until April 2018. Eight locations were selected based on (1) representative of Indonesia's areas (west, central and east); (2) anecdotal and key informant's information about dugong presence availability, and (3) human resources. Those are Aceh, Mentawai, Bangka Belitung and Banten (west parts), West Nusa Tenggara Barat and Sangihe (central parts), Maluku and West Papua (east part). Each location had different PIC from different institution such as CMB-MMAF, P2O-LIPI, Sultan Ageng Tirtayasa University, University of Muhammadiyah Sukabumi, and WWF-Indonesia. A total of 1,044 respondents (Aceh-96 respondents, Mentawai-122 respondents, Bangka Belitung-149 respondents, Banten-141 respondents, Sangihe-121 respondents, West Nusa Tenggara-94 respondents, Maluku-208 respondents and West Papua-113 respondents) have been interviewed. Draft of technical report is available and still being finalized. The results of the survey has strengthened dugong and seagrass database, particularly on distribution, stranding and hunting from community perspective.

Dugong database is under development in Bahasa Indonesia and will be available at http://db.oseanografi.lipi.go.id/dugong, while an online maps showing distribution of dugong events by location and by time will also be available in English at http://db.oseanografi.lipi.go.id/dugong/webgis. Even though both links have not yet been officially launched due to some technical issues to be fixed—including the data characteristics and form structures—they are already accessible to the public and have been managed by DSCP Indonesia's specially assigned administrators (i.e. representatives from each implementing partner).

4.2.1. Facilitate awareness level survey (national stakeholders) before and after campaign in potential project sites – Bintan, Alor, Kei and Kotawaringin Barat

The second phase (post-campaign data) awareness level survey will be conducted in July – August 2018 following the publication of a profile video on dugong and seagrass.

4.2.3 Produce of national awareness campaign materials (newsletter, booklets, poster, etc.)

Most of the designed materials were printed to be used in Jakarta and other relevant working sites.

A short video on dugong and seagrass profile is still being developed with the assisting of WWF-Indonesia's Creative Team and consultants. Documentary on activities in Pantar Strait Marine Reserve Area (SAP) in Alor, East Nusa Tenggara, includes the waters where dugongs have been found in Alor was produced, to shown the commitment of local people in Alor in conserving the natural resources, including dugong and seagrass, in their own area. 4.2.4. Assign dugong and seagrass ambassador (well-known actress)

Since being appointed as a Dugong and Seagrass Ambassador in November 2017, Arifin Putra had participated in two events held by DSCP Indonesia during the past semester. His first participation in the Deep and Extreme Indonesia 2018 Exhibition ("DEI 2018") on 10 March 2018, as one of four speakers who shared their experience and knowledge on seagrass conservation. Arifin's presence at the DSCP Indonesia's booth attracted more visitors, making the booth in total was visited by more than 200 DEI visitors.

DSCP Indonesia's participation in DEI 2018 and Arifin Putra's involvement as an Indonesian dugong ambassador in DSCP Indonesia's booth were covered in WWF-Indonesia website and several mass media, including:

Another event in which Arifin was involved was a gathering titled "Sarasehan Konservasi Duyung" held on 19 April, 2018. The event included a screening for "Cinta untuk Alor" documentary and a discussion on aerial techniques in dugong conservation. In this event, Arifin as one of four speakers, shared to 70 participants in LIPI's Natuna Room his experience during in Alor, seeing a wild dugong for the first time in his life, and making a documentary at the same time. Other speakers were two members of the documentary production team, one of them is a drone pilot. During the event, drone used in dugong conservation not only mentioned as a filmmaking tool, but also as a tool for aerial survey. A dugong researcher, Juraij, shared his knowledge and showed some dugong videos he had made during his activities with DSCP Indonesia.

The gathering was covered only on the official websites of DSCP Indonesia's partners and a section in CNN Indonesia's morning news.

4.2.5. Conduct awareness campaign through national media (newspapers, magazines, televisions, etc.)

DSCP Indonesia launched its official twitter and Instagram accounts at the end of March 2018 following recruitment of a staff specially assigned to manage DSCP Indonesia's social media accounts, including DSCP Indonesia's facebook fan page. The fan page has gained 560 more likes and 590 followers for the past semester. The increase of likes (i.e. 25%) during this semester was higher than that of past semester (i.e. 12%). This was likely due to frequent boosts applied to several Facebook posts, including those that were posted during DSCP Indonesia's participation in DEI 2018 and those that were posted to promote DSCP Indonesia's blogging competition.

A blogging competition was conducted from 22 April to 31 May 2018, with seagrass conservation as its theme. It was promoted on the social media accounts of DSCP Indonesia and on the official website of a community called Telusuri (https://telusuri.id/lomba-blog-padang-lamun/). There were 105 participants from 24 provinces in Indonesia who have sent at least one article published on their blog, personal website, citizen news website, or other publishing platforms (e.g. Medium.com). DSCP Indonesia have chosen three winners with best quality of articles—one participant being "The Most Favorite" had the highest number of comments and shares of his article in his own social media accounts. The winners received shopping vouchers and exclusive souvenirs from DSCP Indonesia (e.g. water bottle, stickers, pins, and DSCP Indonesia factsheet).

One month after DEI 2018, DSCP Indonesia invited journalists from Jakarta to Kotawaringin Barat, the media trip focusing on Bogam Bay Village, on 10-12 April 2018. After Kotawaringin Barat, the journalist visited several areas in Bintan on 24-27 April 2018. Local journalists in each trip destination were also invited. The trips were conducted to promote the dugong conservation efforts and the DSCP Indonesia's activities in sites to the public through online and offline mass media.

Following the media trips, two media visits were conducted to improve the quality of media engagement. The meeting with editorial boards of two major news offices in Indonesia, they were Tempo.co and of Media Indonesia. During the visit, DSCP Indonesia team explained about DSCP and the importance of dugong and seagrass conservation and asked for more active involvement from both mass media. DSCP Indonesia team also shared its activities calendar with Tempo.co and Media Indonesia to gain the media's participation. Other media visits are planned to be conducted in the next semester.

4.2.6 Participate in national events (national seminar and symposium, environment day, etc.)

From February 14th to 18th, 2018, DSCP Indonesia participated in Penyengat Island Festival (FPP 2018), a booth with volunteers from Raja Ali Haji Maritime University (UMRAH) was opened to increase the awareness of local and international visitors of FPP 2018 on dugong and seagrass issues. The activity inside the booth was limited to introducing DSCP Indonesia through giving factsheets to the visitors. The booth was visited by 166 persons, including two journalists (i.e. from The Jakarta Post and TV Kepri). However, only TV Kepri who covered the activity (https://www.youtube.com/watch?v=ECBPXVWgPzE).

From March 8th to 11th, 2018, DSCP Indonesia participated in DEI for the second time to increase the awareness of the visitors of DEI 2018 on dugong and seagrass issues. DSCP Indonesia shared a 6 x 3 meters booth with WWF-Indonesia's programs, such as Marine Buddies and Signing Blue. To achieve its objectives, DSCP Indonesia provided interactive games with DSCP Indonesia exclusive souvenirs as prizes, shared DSCP Indonesia factsheets and hosted three knowlege sharing and discussion sessions named as "Disko" (*Diskusi Konservasi* or Conservation Discussion).

On 10 March 2018, Sheyka N. Fadela from WWF-Indonesia and Sekar Mira from Research and Oceanography Center – Indonesian Institute of Sciences (P2O – LIPI) shared the knowledge on dugong stranding in Indonesia. On the same day, a sharing session on seagrass conservation was also presented by Ahmad Sofiullah from Directorate of Marine Conservation and Biodiversity – Ministry of Marine Affairs and Fisheries (CMB-MMAF), Rahmat Nurdin and Udhi Hernawan from P2O – LIPI, and Arifin Putra, actor and Indonesian dugong-seagrass ambassador. On the last day of DEI 2018, Ahmad from CMB-MMAF and Casandra Tania from WWF-Indonesia presented some information on being a responsible tourist and interaction with the wild dugongs.

DSCP Indonesia's booth was visited by many visitors, 250 of them was recorded their personal information. Meanwhile, DSCP Indonesia's Facebook account had an increase of 150 likes during the DEI 2018, and several posts on knowledge sharing session promotions were liked by more than 100 Facebook accounts.

From May 4th to 5th, 2018, DSCP Indonesia participated in International Conference on Building Synergy on Diversity in the Borders: Embodying the Global Maritime Axis organized by Tribuana University in Kalabahi, Alor. The representatives from DSCP Indonesia gave a greeting and showed the attendants the "*Cinta untuk Alor*" documentary with hope that it would increase the awareness of the local community, particularly student and academics on the importance of preserving their local pride through dugong and seagrass conservation.
